DESCRIPTION (subject area, expectations, comments):

Conducting research in the field of experimental cognitive psychology, including research in the field of memory psychology and assessment and decision-making conducted at the Department of Cognitive Psychology; publication of results in international journals with IF; teaching classes in the psychology of cognitive processes (exercises)

PROPOSED EMPLOYMENT PERIOD: 2 years with the possibility of extension

I. Competition conditions:

The competition is open to persons who meet the conditions specified in Article 113 of the Act of 20 July 2018 - Law on Higher Education and Science (Journal of Laws of 2018, item 1668, as amended) and in the Statutes of the Cardinal Stefan Wyszyński University, and who have:

- professional title/academic degree/academic title: Master's degree in psychology or cognitive science
- at least one publication or presentation at an international conference in the field of cognitive psychology (or cognitive science, neuropsychology or psycholinguistics)

In addition, the following criteria will be important in the evaluation of candidates:

- teaching achievements (especially experience in teaching cognitive psychology) and organisational skills
- ability to programme psychological experiments (e.g. in E-Prime, PsychoPy, Inquisit, MATLAB or other software)
- master's thesis grade and topic (preferably in the field of cognitive psychology, especially memory or evaluation and decision-making)
- ability to study psychophysiological or neuropsychological correlates of cognitive processes (e.g. eye tracking, VR, EEG)

- knowledge of methods for modelling cognitive processes and using software for data analysis with these models

II. Required documents:

1) Application to the Rector of UKSW for employment as an assistant, with justification. The application should include the following statement: "I hereby consent to the processing and use of my personal data disclosed in the application documents in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC - GDPR - 4.5.2016 EN Official Journal of the European Union I. 119/1 by Cardinal Stefan Wyszyński University in Warsaw for the purpose of conducting the University's recruitment process."

2) curriculum vitae/CV;

3) a copy of the letter conferring the academic title/degree/professional title of Doctor of Psychology

4) list of scientific and teaching achievements - including a list of publications from the last 5 years, including information on published monographs, articles, reviews, active participation in national and international conferences, participation in scientific projects, including in the role of manager, as well as a list of classes taught to students (classes in English are welcome);

5) information on organisational achievements;

6) a statement that UKSW will be the primary place of employment;

7) other documents at the candidate's discretion, if applicable.

3. Your personal data will be processed for the purpose of the recruitment process on the basis of Article 221 of the Labour Code and, in the case of providing a wider range of data, on the basis of Article 6(1)(a) of the GDPR - your consent.
4. Access to your personal data within the organisational structure of the University will be limited to employees authorised by the Controller to the extent necessary.
5. Your personal data will not be disclosed to other entities, except for those authorised by law.
6. Your personal data will be stored for the period necessary to complete the recruitment process (up to 12 months from the conclusion of the recruitment process).
7. You have the right to access your data, the right to rectify, delete, restrict processing, the right to transfer data, the right to object to processing, and the right to withdraw consent.
8. You have the right to withdraw your consent to the processing of personal data at any time, which will not affect the lawfulness of the processing that was carried out on the basis of your consent prior to its withdrawal.
9. You have the right to lodge a complaint with the President of the Personal Data Protection Office if there are grounds to believe that your personal data is being processed by the controller in breach of the General Data Protection Regulation of 27 April 2016.
10. Providing personal data is voluntary, but necessary to participate in the recruitment process within the scope specified in Article 22 § 1 of the Labour Code, and voluntary in other respects.
11. Decisions will not be made in an automated manner, and you will not be subject to profiling.
